## ORDINANCE 2018 – 03 *LAKE ISABELLA ZONING MAP AMENDMENT*

The Village of Lake Isabella hereby ordains:

### SECTION 1 PURPOSE

The purpose of this Ordinance is to amend the zoning map of the Village of Lake Isabella. Specifically, this ordinance rezones Lots 19 – 31 of the recorded plat Lake Isabella Airpark from Airport Residential to Lake Residential – 1. These lots are located in an area where there are no means of access to the runway at the Lake Isabella Airport, and are outside of any identified hazard zones of the airport’s approved Aircraft Approach Plan (AAP). The purpose of this rezoning is to carry out the direction of the Master Plan, which states that the Village should “consider changing the zoning classification along the north side of Bonanza to Lake Residential 1 (LR-1), or modify the existing the zoning regulations in the Airport Residential (AR) district to create a safeguard which would prohibit the development of airplane hangars on the north side of Bonanza Lane.” By rezoning these lots from Airport Residential to Lake Residential – 1, the ability to develop aircraft hangars would be eliminated as a permitted land use for these parcels..

### SECTION 2 ZONING MAP AMENDED

The official zoning map of the Village of Lake Isabella is hereby amended by rezoning the following lots located in the Lake Isabella Airpark plat from Airport Residential to Lake Residential - 1:

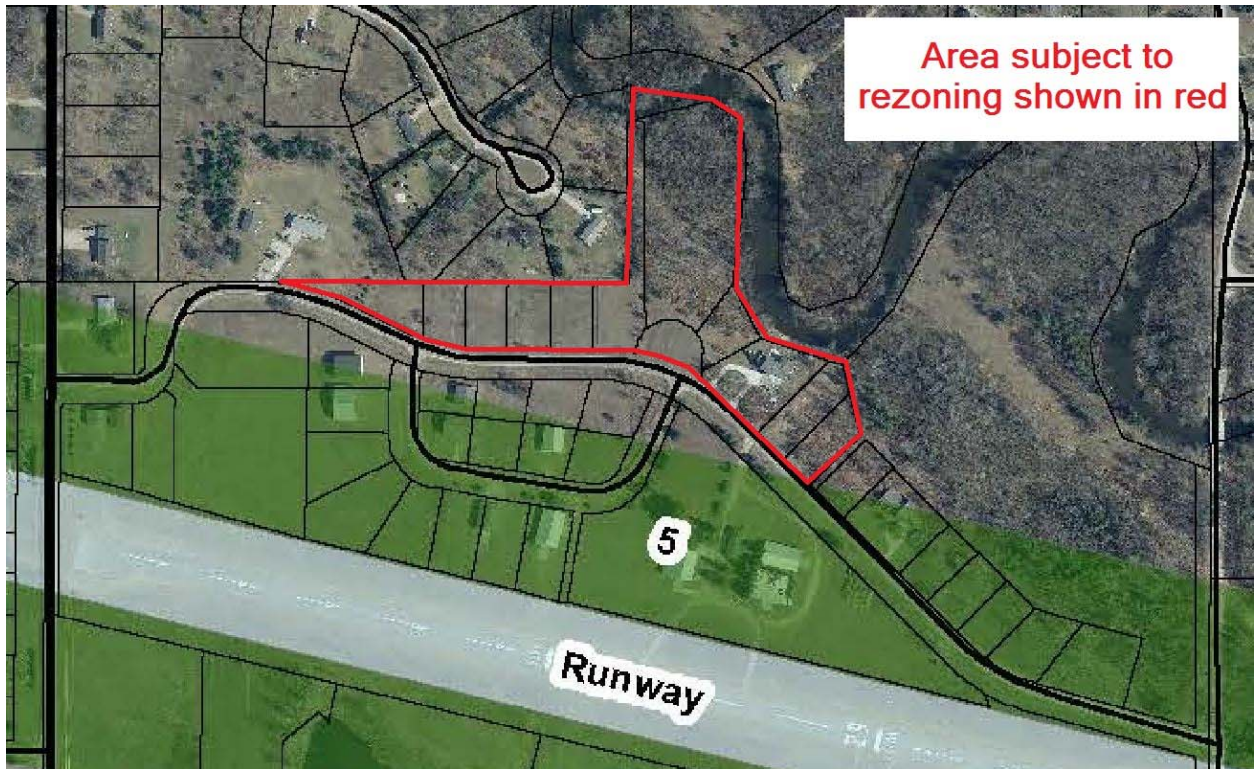
**SECTION 4 ORDINANCES REPEALED**

**SECTION 5 EFFECTIVE DATE**

This Ordinance shall take effect and be in force upon the expiration of 7 days of the date when the notice of adoption for this Ordinance is published in a newspaper of general circulation in the Village of Lake Isabella. This Ordinance and attached document shall be codified, edited for typos and grammatical errors, and enumerated in accordance with the codification procedure of the Village of Lake Isabella.
